Thank you for your interest in Calvary Christian Academy enrollment. We are a legal, private school with a heart to serve Christian homeschooling families who desire simple, record keeping support and the fellowship of other families through field trips and social events. We sincerely believe homeschooling parents should have the freedom to choose their own educational methods and materials. Calvary Christian Academy can help your family maintain that freedom while holding a high standard in response to California law regarding homeschooling.

Our homeschool adventure began in 1996 with our oldest child. Our family now includes five children; ages 28 (graduated in June 2008), 24 (graduated in June 2012), 20 (graduated in June 2016), and 12 ½ year old twins. In the last 22 years of homeschooling our children have been involved in team sports, park day groups, special interest groups, and a wide variety of church ministries and activities. It has been a rich experience for all of us. We understand the busy schedules of homeschooling families. It is our desire to assist families without the burden of mandatory meetings or unnecessary paperwork.

HSLDA membership is required to be enrolled in Calvary Christian Academy. Membership applications can be completed online at www.hslda.org

Calvary Christian Academy provides the following to our enrolled families:

- ❖ Filing of a private school affidavit for each child enrolled in our school
- ❖ Requesting of your child's cumulative file from their previous school
- ❖ Maintenance of your child's cumulative file
- ❖ Forms for Course of Study, Attendance, Report Cards, and Immunization Records/waivers
- ❖ High School Diplomas upon graduation
- ❖ High School Transcripts
- ❖ Curriculum guidance upon request (appointment required)
- ❖ Scheduled field trips and social events to allow opportunities for fellowship and rich learning experiences (one every other month).

- ❖ \$150.00 per year per family if enrolling **on or before June 30th**
- ❖ \$175.00 per year per family if enrolling **July 1st - July 31st**
- ❖ \$200.00 per year per family if enrolling **August 1st or thereafter**

- ❖ We understand that Calvary Christian Academy was founded to assist Christian, home schooling families in their efforts to educate their children.
- ❖ We understand and accept that although Calvary Christian Academy is keeping our children's cumulative records, the school is in no way responsible for the actual education of our children. We, the parents, are responsible for providing all curriculum materials and instruction and agree to provide parental supervision during school hours.
- ❖ We understand and accept that Calvary Christian Academy can not offer legal immunity. It is therefore mandatory to establish and maintain membership with Home School Legal Defense Association. (Membership may be established online by visiting www.hslda.org)
- ❖ We understand and accept that it is our responsibility to maintain updated medical records or waivers as mandated by law.
- ❖ We understand and accept that in order to comply with California State Law, instruction must be given in English in the core subjects to include English, Mathematics, Social Studies, Science, Fine Arts, and Physical Education.
- ❖ We understand and accept that we are responsible for submitting our children's individual report cards, attendance records, and enrollment forms.
 - Enrollment forms and fees in full are due no later than June 30th or late fees will apply
 - Completed course of studies are due no later than September 30th
 - Completed yearly report cards and attendance records are due no later than June 30th

California State Law mandates that *public* schools provide education of at least 175 days per calendar year. This number may include field trip and co-op class days.

Field Trip Policies

Field trips have a wonderful way of bonding home schooling families even closer together and provide wonderful family memories. They can also reinforce a topic being studied in the home, or introduce a new topic or discussion for future study. Children retain information better from hands-on learning experiences. Field trips also provide a unique opportunity to be a positive witness for home schooling and for Christ. The memories my children and I have created on field trips are irreplaceable.

To make our trips as enjoyable as possible for everyone, please observe the following:

- ❖ Field trips are scheduled for the families enrolled in Calvary Christian Academy and Investigating Homeschooling *only*. If you have a family member (mom, grandparent, etc...) that you desire to bring as a guest, please call me and I will do my best to make exceptions on a case by case basis.
- ❖ To sign up for a field trip, please call Nedra at (951) 361-0438. State your family's name, the number of adults and children in your group attending, and please promptly send your field trip fees by the deadline date listed for each trip to: 5212 Sulphur Drive, Mira Loma, CA, 91752. Checks can be made out to either Nedra Patton or Calvary Christian Academy. **Your spot will not be guaranteed until payment is received.**
- ❖ If you have signed up for a field trip and find out at some point that you cannot attend, please let me know as soon as possible. This saves time and confusion and allows the field trip location to properly prepare for our group according to number attending.
- ❖ At least one parent must attend field trips with their child(ren). If for some reason you are unable to attend with your child(ren), please let me know which adult will be taking your place and will be responsible for your children. It will then be your responsibility to provide that adult with a medical release form for each of your children.
- ❖ Field trip fees are not refundable. We depend on a certain number of families to schedule our trips and many trip locations require a non-refundable deposit.
- ❖ For the courtesy of others, please try to be on time. We try to allow enough time for checking in procedures and traffic, but out of respect for each other and our field trip host location, we will start on time! If you need to contact me on the day of a field trip you may call my cell phone number: (951) 452-2968. Please use this number **ONLY** if it is too late to contact me at my home number.
- ❖ When you arrive at the field trip destination, PLEASE keep your children with you at all times. Please be respectful of our field trip location's property and/or business. Remember that they will form their opinion of home schoolers based on our children's behavior.
- ❖ Wholesome friendships are encouraged between boys and girls. Students should look upon each other as brothers and sisters in Christ, and should refrain from demonstrating personal affection during all field trips (Romans 12:10). Christ-like behavior is expected at all school functions.
